BMP Title: Facilities Inventory

BMP Description:

The UMN-TC maintains a written/mapped inventory of permittee owned/operated facilities that contribute pollutants to stormwater discharges. The facilities have BMPs implemented to prevent or reduce pollutants in stormwater discharges.

The facilities are defined as follows:

- **Equipment Storage and Maintenance:** All equipment (excluding vehicles parking) used for exterior campus maintenance activities. UServices (municipal operations) only. Does not include farm operations.
- **Parks:** Dedicated green space, managed by Landcare, not associated with a specific building. RecWell facilities without controlled access. Does not include Athletics facilities.
- **Pesticide Storage:** Only bulk or palletized quantities stored for distribution or large-scale application. Landcare operations only. Does not include farm operations. All storage locations are indoors.
- **Public Parking Lots:** Public surface parking lots that contain revenue collecting equipment on more than 12 stalls. Does not include on-street parking.
- **Public Golf Course:** Public golf course
- **Public Swimming Pools:** Pools available for students or community swim use. Does not include private residence or therapeutic pools. All public pools are located indoors and discharge to the sanitary sewer. There is no discharges of pool water to the storm sewer.
- **Salt Storage:** Only bulk or palletized quantities stored for distribution or large-scale application. Includes all chloride products.
- **Snow Storage:** Sites that hold hauled snow; referred to as "snow dumps"
- **Vehicle Storage and Maintenance Yards:** Sites where rental fleet and service vehicles (municipal operations) are stored, and provides fueling, fleet maintenance, and washing.
- **Materials Storage Yards:** Stockpiles that are needed for municipal operations. The complete materials list is: Landscape materials recovery, sand, gravel, mulch, excavated materials/spoils, removed sediment, compost, street sweepings, soil, other.

Facilities not applicable to UMN-TC MS4: hazardous waste disposal, hazardous waste handling and transfer, landfills, solid waste handling and transfer, public works yards, recycling
